Schoolwide Title I Parent Involvement Policy

PART I. GENERAL EXPECTATIONS

The Mahanoy Area School District agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—

- (A) that parents play an integral role in assisting their child's learning;*

- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*
- (D) the carrying out of other activities, such as those described in section 1118 of the ESEA.*

PART II. DESCRIPTION OF HOW DISTRICT WILL IMPLEMENT REQUIRED DISTRICT WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS

1. The Mahanoy Area School District will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of the ESEA:
 - a.) *Invite parents to attend the annual informational and organizational meeting concerning our Title Parent Council and Federal Grants.*
 - b.) *Complete parent surveys and return them to school.*
 - c.) *Attend workshops conducted by IU 29.*
 - d.) *Invite parents to attend our "Family Reading Night" activities.*

2. The Mahanoy Area School District will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - a.) conduct parent meetings at least once yearly to review school policy and make improvements with parent input taken into consideration.

3. The Mahanoy Area School District will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:
 - a.) *Meet the Teacher-conducted in the beginning of the year.*
 - b.) *"Friday Folder" information provided to parents each week including all assessment tests, observations, and suggestions.*
 - c.) *Discipline Tracker- not accessible to parents (if necessary).*
 - d.) *Telephone parent/teacher conferencing whenever necessary.*
 - e.) *Accelerated Reader Enterprise*
 - f.) *Referral to IST Support when necessary*
 - g.) *Referral to SAP team when necessary*
 - h.) *CSIU Student Information System*

The Mahanoy Area School District will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs: [Insert programs, such as: Head Start, Reading First, Early Reading First, Even Start, Parents As Teachers, Home Instruction Program for Preschool Youngsters, and State-operated preschool programs], by:

- a.) *Inviting parents of all Head Start Students to Our "Family Reading Night" programs.*

 - b.) *Inviting all Head Start Students, Teachers and Parents to the "Kindergarten in a Nutshell" Program.*

 - c.) *Inviting all Head Start parents whose children have IEPs to meet with their child's Kindergarten teacher at the end of their Head Start year.*

5. The Mahanoy Area School District will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more

effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.

a.) The evaluation will be conducted during one of our Parent meetings and will be conducted by the President of our Parent group and the Federal Programs Coordinator. Parents will have a copy of the present policy in hand and we will review item by item. Suggestions from participants will be welcomed and recorded. We will then vote on the suggested changes and include them in the revised parent policy.

1. The Mahanoy Area School District will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:

A. The school district will, with the assistance of its Title I, Part A schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph --

- the State's academic content standards,
- the State's student academic achievement standards,
- the State and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

a.) Parents will be invited to attend all parent workshops conducted by our IU. Many of the topics listed above are covered at these workshops.

b.) Parents receive informative bulletins on the back of our monthly "News Bearer" that also address most of these areas.

B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

a.) offer parents the opportunity to attend IU and district workshops that will involve literacy training so that parents can work with their child to improve academic achievement.

b.) offer parents literature that they may read which will aide in raising their child's academic achievement.

c.) parents may use our computer lab facilities at our districts high school.

- C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

a.) opening our schools to parents for such activities as "Meet the Teacher Night," "Parent - Teacher Conferences," "Family Reading Night," weekly parent bulletins called "Friday Folders", telephone conferences, and IST meetings.

- D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

a.) invite parents of Head Start students to all "Family Reading Night" activities and "Kindergarten in a Nutshell". Transitional meetings are also held for students with IEP. District evaluations and MDSs are then scheduled as necessary.

- E. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

a.) parents receive all information well in advance of any event, reminders are also sent home in a flier format, and many times parents are also telephoned one day prior to the event to remind them that they are attending. Parents are always welcome to call or email with any questions.

- developing appropriate roles for community-based organizations and businesses, including faith-based organizations, in parental involvement activities; and
- providing other reasonable support for parental involvement activities under section 1118 as parents may request.]
